## Information to Customers/Suppliers regarding privacy (protection and transfer of personal data)

Pursuant to articles 13 and 14 of EU Regulation 679 of 2016, the **Customer / Supplier** has the right to be informed about the purposes and methods with which the data provided by them will be processed.

GB Pharma S.r.I., in compliance with its **Privacy policy** and contractual **agreements**, informs you of the following.

The personal and sensitive data provided by you directly or otherwise acquired will be processed and stored in our paper and electronic archives, in compliance with the provisions of the law (EU Regulation 679 of 2016), for the security measures adopted.

The processing of personal data will take place in compliance with the rights, fundamental freedoms, and dignity of persons, according to the principles of loyalty, correctness, impartiality, lawfulness, and transparency and will be aimed solely at the exclusive obligations relating to administrative, social security, insurance, tax obligations and the management of the contract including any presence at the company's offices.

It should be noted that the processing of data may be carried out without consent, as well as in court, pursuant to Article 6 paragraph 1 in the following cases:

- a) il processing is necessary for the execution of a contract of which the interested party is a party or for the execution of pre-contractual measures adopted at the request of the same;
- b) the processing is necessary for compliance with a legal obligation to which the data controller is subject;
- c) processing is necessary to safeguard the vital interests of the data subject or of another natural person;
- d) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller;
- e) processing is necessary for the pursuit of the legitimate interests of the controller or of a third party, provided that the interests or fundamental rights and freedoms of the data subject which require the protection of personal data do not prevail if the data subject is a minor.

We also inform you that the Company will be required to register and process also the "particular data", meaning for such, according to the provisions of Article 9 of the aforementioned Regulation, personal data suitable to reveal racial and ethnic origin, religious, philosophical or other beliefs, political opinions, membership of parties, trade unions, associations or organizations of a religious nature, philosophical, political or trade union, personal data revealing health status and sex life, genetic and biometric data.

It should be noted that the data may only be processed with the written consent or for the above conditions.

The data controller (meaning the natural person, legal person, or any other body or association responsible for decisions about the purposes, methods of processing personal data and the tools used), pursuant to Article 13 of the regulation is GB Pharma S.r.l. in the figure of its legal representative. The data will be kept for 10 years from the termination of the contractual relationship, unless otherwise legally obliged.

Pursuant to articles 15 to 22 of the Regulation, you may exercise the following rights:

- Right of access to data;
- Right to rectification;
- Right to erasure;
- Right to restriction;
- Right to portability;
- Right to object;
- Right to be informed about processing carried out through automated decision-making processes relating to individuals, including profiling.
